

Conditions:

1. This approval is limited to that specified in the scope of approval section of the approved continuing airworthiness management ~~exposition~~ as referred to in Part-M Section A Subpart G, and
2. This approval requires compliance with the procedures specified in the approved continuing airworthiness management organisation exposition, and
3. This approval does not constitute an authorization to operate the types of aircraft listed in the approval schedule. The authorization to operate the aircraft is the Air Operator Certificate (AOC).
4. This approval is limited to the aircraft registrations specified in the AOC.
5. This approval is valid whilst the operator remains in compliance with Part-M Section A Subpart G and that the applicable Aircraft Maintenance Programme, MEL and aircraft Technical Log System remain approved.
6. Subject to compliance with the foregoing conditions, this approval shall remain valid unless the approval has previously been surrendered, superseded, suspended or revoked.
7. Where the technical services organisation is different to the operator, this approval remains valid subject to such organisation(s) fulfilling applicable contractual obligations.
8. Termination, suspension or revocation of the AOC automatically invalidates the present approval.




